PLEASE TAKE NOTICE THAT on April 1, 2018, the debtors and debtors in possession (collectively, the “Debtors”) in the above-captioned chapter 11 cases, filed with the Court the *Motion of Debtors for Entry of Interim and Final Orders Authorizing Continued Performance of Obligations Under Intercompany and Shared Services Agreements* [Docket No. 12] (the “Motion”). On April 3, 2018, the Court entered the Interim Order Authorizing Debtors to Continue Performance Obligations Under Intercompany Agreement [Docket No. 151].
