PLEASE TAKE NOTICE that on December 17, 2020, the Wind-Down Debtors filed their Seventeenth Omnibus Objection to Certain Proofs of Claim (Reclassified Claims) (“Seventeenth Omnibus Objection”) [Docket No. 2209];

PLEASE TAKE FURTHER NOTICE that on January 13, 2021, Verlean Everett filed her Motion to Reinstate Claimants Claim Deleted Due to Debtors Error in Amended Claims (“Everett Motion to Reinstate”) [Docket No. 2387];

PLEASE TAKE FURTHER NOTICE that on February 3, 2021, the Wind-Down Debtors filed its *Objection to Everett Claim* [Docket No. 2538] (the “Everett Objection”).

PLEASE TAKE FURTHER NOTICE that the hearing on the Everett Objection previously set for March 15, 2021, and the Seventeenth Omnibus Objection, solely as to the Claim No. 4691 filed by Verlean Everett, previously scheduled for March 16, 2021, and the Everett Motion to Reinstate has been set for **April 5, 2021 at 11:00 a.m. (prevailing Central Time)** before David R. Jones, Chief United States Bankruptcy Judge, in Courtroom 400 of the United States Bankruptcy Court, 515 Rusk Street, Houston, TX 77002.

PLEASE TAKE FURTHER NOTICE that audio communication will be by use of the Court’s dial-in facility. You may access the facility at (832) 917-1510. You will be responsible for your own long distance charges. Once connected, you will be asked to enter the conference room number. Judge Jones conference room number is 205691.

PLEASE TAKE FURTHER NOTICE that you may view video via GoToMeeting. To use GoToMeeting, the Court recommends that you download the free GoToMeeting application. To connect, you should enter the meeting code “JudgeJones” in the GoToMeeting app or click the link on Judge Jones’ home page on the Southern District of Texas website. Once connected, click

Under “Electronic Appearance” select “Click here to submit Electronic Appearance”. Select the case name, complete the required fields and click “Submit” to complete your appearance.

PLEASE TAKE FURTHER NOTICE that if you object to the relief requested or you believe that emergency consideration is not warranted, you must either appear at the hearing or file a written response prior to the hearing. Otherwise, the Court may treat the pleading as unopposed and grant the relief requested.
