**ORDER SCHEDULING EXPEDITED TELEPHONIC STATUS CONFERENCE**

On July 27, 2020, Remington Outdoor Company, Inc. and its affiliated entities filed voluntary petitions for relief under Chapter 11, Title 11 of the United States Bankruptcy Code. A Status Conference will be held in this case on the Court's own motion pursuant to 11 U.S.C. § 105(d) to discuss the expeditious and economical resolution of the case, including scheduling First Day Motions.

**IT IS FURTHER ORDERED** that counsel for the Debtor must immediately serve a copy of this Order upon such counsel as are appropriate for this Status Conference.

The Status Conference will be held via an AT&T call-in number. The dial-in number is **1-877-336-1280**. When prompted, enter the access code **#2749965**. There is no security code, and please do not select any other feature. Parties should call in **five minutes** prior to the start of the hearing. Once connected, please mute your phone until your case is called. To avoid disruption, telephonic hearing participants are expected to call from a quiet location and are not permitted to use a "speaker" function or to place the call on hold (as this may cause music or other noises to play during the hearings of other participants). Participants are encouraged to call from a landline if possible.
