**COMMONWEALTH OF KENTUCKY ENERGY AND ENVIRONMENT CABINET’S
MOTION TO COMPEL DEBTORS TO BRING ALL KENTUCKY MINING AND
KPDES PERMITS INTO COMPLIANCE WITH STATE ENVIRONMENTAL LAWS**

Comes now, the Commonwealth of the Kentucky (“Commonwealth”), Energy and Environment Cabinet, (hereinafter the “Cabinet”), and for its Motion to Compel Debtors to Bring all Kentucky Mining and KPDES Permits into Compliance with State Environmental Laws, hereby respectfully states as follows:

INTRODUCTION

Blackjewel, L.L.C., and its affiliated debtors and debtors-in-possession (collectively, the “Debtors”) are in violation of Kentucky’s mining and environmental laws and have failed to comply with the conditions and requirements of their surface mining and reclamation permits and Kentucky Pollutant Discharge Elimination System (“KPDES”) permits. Since the Cabinet responded to the Debtors’ Letter (Docket No. 1540) on January 13, 2020, the number of performance standard violations incurred by the Debtors has continued to climb, now up to 606

outstanding violations of Kentucky’s mining laws codified in KRS Chapter 350 and the regulations promulgated thereunder, across 203 Kentucky mine permits.² In addition to these 606 violations the Debtors have accrued 13,125 violations of their KPDES Permits, primarily the result of failing to submit discharge monitoring reports to the Cabinet.³ Yet, instead of using the Estate’s limited resources to maintain their operations necessary to avoid causing harm to the affected land and water, the Debtors continue to spend millions of dollars on professional fees – an amount in excess of five million dollars (\$5,000,000.00) for the third quarter calendar year 2019 alone. For this reason, the Court must grant the Cabinet’s Motion to Compel Compliance to ensure that the land and the people of Kentucky are not harmed by the Debtors’ failure to comply with Kentucky’s environmental laws.

STATEMENT OF FACTS

1. The Debtors as the permittees and responsible parties on numerous coal mining permits in the Commonwealth of Kentucky, have failed to comply with state environmental laws. The Cabinet now seeks relief from this Court pursuant to 28 U.S.C.A. § 959(b) to compel Debtors to bring all Kentucky mining permits, on which they remain the permittee, into compliance with the Kentucky statutes and regulation that govern coal mining permits.

² The Surface Mining Control and Reclamation Act of 1977, Public Law 95-87, and its subsequent amendments is the primary Federal law that regulates the environmental effects of surface coal mining and surface impacts incident to underground coal mines in the United States. Kentucky is a SMCRA primacy state with primary administrative responsibility for implementing the Act within its own territorial boundaries under Federal oversight by the U.S. Department of the Interior.

³ The KPDES program is part of Kentucky’s state primacy program for implementation of the Federal Clean Water Act (“CWA”). The Clean Water Act (i.e. Federal Water Pollution Control Act Amendments of 1972), Public Law 92-500, and its subsequent amendments is the primary federal law regulating water quality in the United States. Like SMCRA, the CWA allows for delegation of primary responsibility for enforcing the CWA to the states. Because the CWA regulates water discharges from surface coal mining and reclamation activities, Kentucky mining facilities are required to obtain and comply with KPDES permits in addition to SMCRA permits.

2. At the time of the filing of its Chapter 11 petition, Debtors held 207 mining permits in the Commonwealth of Kentucky. The permits for mines in Kentucky are issued and regulated by the Cabinet pursuant to KRS Chapter 350 and the regulations promulgated pursuant thereto in Title 405 of the Kentucky Administrative Regulations.
3. Through the course of the §363 sale process and subsequent *de minimis* sales, Debtors sold a substantial number of their Kentucky mining permits. There are currently 43 permits that have not been sold, and there are 202 outstanding violations on these same 43 permits with no effort by the Debtors to abate these violations.
4. Additionally, very few of the permits that were “sold” have been transferred to the purchasers. Only four out of the total sold have been transferred. Without an administrative transfer of the permit to purchasers, Debtors remain the permittee and responsible for abating all violations on the permits until transferred. KRS 350.130; KRS 350.135. In regard to permits that have been sold but not yet transferred, there are 404 outstanding violations, and with few exceptions, no work is being done to abate the violations.⁴
5. On January 13, 2020, the Cabinet submitted a letter to the Court (Docket No. 1617) explaining that the Debtors accounted for approximately thirty (30) percent of all outstanding mining violations in the Commonwealth of Kentucky. At that time, the Debtors had incurred one hundred fifty-seven (157) notices of non-compliance. Notices of noncompliance can include multiple performance standard violations, such as failure to properly maintain sedimentation ponds, conducting contemporaneous reclamation, and causing an off-permit disturbance, just to name a few. The Cabinet expressed its concern

to the Court regarding both the failure of purchasers to begin the permit transfer process as well as its serious concerns regarding Debtors continued lack of efforts to abate the outstanding violations. Debtors have still failed to abate the pre-existing violations and continue to incur additional violations.

6. Post petition, Debtors have been assessed \$11,660,030 in civil penalties, the entire amount of which remains unpaid as of this date. These payments are entitled to administrative priority. *U.S. Dep't of Interior v. Elliott*, 761 F.2d 168 (4th Cir. 1985).
7. Instead of using funds to comply with the Cabinet's orders to undertake remedial measures, preserve assets of the estate, and avoid incurring additional post-petition penalties, Debtors have spent in excess of five million dollars, on professional fees and more than two hundred twenty-one thousand dollars in expenses in their Chapter 11 bankruptcy from July 1, 2019 through September 30, 2019 *alone*. FTI Consulting, Inc. has invoiced the estate for an additional two million, seven hundred thirteen thousand, ninety-five dollars, and ninety cents (\$2,713,095.90) for services rendered from October 1, 2019 through March 31, 2020.

The Requirements of 28 U.S.C.A. § 959(b):

8. Courts have continually held debtors-in-possession responsible for complying on an ongoing basis with environmental laws based on 28 U.S.C.A. § 959(b). This provision requires the debtor-in-possession to manage and operate the property of the estate in accordance with state law and provides as follows:

Except as provided in section 1166 of title 11, a trustee, receiver or manager appointed in any cause pending in any court of the United States, including a debtor in possession, shall manage and operate the property in his possession as such trustee, receiver or manager according to the requirements of the valid laws of the State in which such property is situated, in the same manner that the owner or possessor thereof would be bound to do if in possession thereof.

9. Section 959(b) makes clear that Congress did not intend for debtors to be able to ignore state law when operating under bankruptcy protection. *See Midlantic Nat'l Bank v. N.J. Dep't of Env'tl. Prot.*, 474 U.S. 494, 505 (1986). ““There is no exception for debtors who would be inconvenienced or burdened by state laws.”” *In re Grace Coal Co., Inc.*, 155 B.R. 5, 6 (Bankr. E.D. Ky. 1993) (*citing Wilner Wood Prods. v. State of Me., Dep't of Env'tl. Prot.*, 128 B.R. 1 (D. Me. 1991)).
10. Debtors have failed to operate the property of the estate (*i.e.*, the permits) in accordance with Kentucky state laws since the inception of this bankruptcy proceeding.

Ongoing Kentucky Surface Mining Violations

11. As of the date of this filing, there are 606 outstanding violations on the 203 permits for which Debtors remain responsible, 450 of which have been incurred by Debtors post-petition.
12. The Cabinet has attached a spreadsheet detailing the ongoing violations for both Blackjewel, LLC and Revelation Energy, LLC (attached hereto as “Exhibit A”).

Ongoing Water Monitoring Violations

13. In addition to the violations of Kentucky’s mining laws, Debtors have incurred 13,125 outstanding Kentucky Pollutant Discharge Elimination System (“KPDES”) Permit violations, including failure to monitor, missing data, and missing discharge monitoring reports. KRS 224.80-120; 401 KAR 5:065. The Cabinet has attached a summary of the Division of Enforcement stating the number of KPDES Permit Violations for Blackjewel LLC and Revelation Energy, LLC (attached hereto as “Exhibit B”)

Environmental Issues and Reclamation Concerns

14. As is further explained below, Debtors' failure to comply with Kentucky mining statutes and regulations threatens human health, safety and the environment. Permit conditions required by both federal and state law protect the quality of water that downstream residents use for drinking and recreation, as well as aquatic habitat. Those permit conditions also protect the safety and stability of mine sites to prevent downstream flooding and landslides. These laws are a valid exercise of Kentucky's police powers under the statutory scheme which grants Kentucky primacy under the federal Office of Surface Mining for enforcement.
15. Debtors' failure to remain in compliance has both immediate and long-term consequences both for the environment and for the Commonwealth.
16. The immediate concerns raised as a result of Debtors' failure to remain in compliance include pollution of the waters of the Commonwealth. Holding ponds with substandard water quality are at a high risk for discharging metals and suspended solids into adjacent rivers and streams, which in turn harms and endangers aquatic life. Failure to properly reclaim surface mines can lead to saturation of hillsides causing slides that could endanger the lives and the property of residences below. Failure to reclaim underground mine pools can also cause slides as well.
17. The long-term issues are just as significant and are much more troubling given that the Debtor entities may be long gone when it comes time to fully reclaim these permits and restore the land to its safe and natural condition.

CONCLUSION

18. While Debtors have abated a handful of minor violations, the urgency of abatement compared to the rate of accruing noncompliances and cessation orders demonstrates that Debtors are not working seriously to address violations and other underlying obligations.

19. In addition, each additional violation incurs a post-petition penalty to the estate, payment of which is entitled to administrative priority. *U.S. Dep't of Interior v. Elliott*, 761 F.2d 168 (4th Cir. 1985).

WHEREFORE, the Cabinet requests this Court enter an order pursuant to 28 U.S.C.A. § 959(b) to (a) compel Debtors to bring all mining permits in the Commonwealth of Kentucky, on which they remain the permittee, into compliance with the Kentucky statutes and regulation that govern coal mining permits; (b) submit any missing discharge monitoring reports and data as required by the terms of their KPDES permits; and (c) comply with the terms of their KPDES and Surface Mining and Reclamation Permits.
