





THIS bankruptcy case was filed on October 1, 2020. An Application for Designation as Complex Chapter 11 Case was filed. After review of the initial pleadings filed in this case, the Court concludes that this case constitutes a complex Chapter 11 case.

IT IS HEREBY ORDERED that the request set forth in the Application for Designation as Complex Chapter 11 Case pursuant to the Court's General Order Governing Procedures for Complex Chapter 11 Cases is **HEREBY GRANTED**; and it is further

ORDERED that the Guidelines Establishing Case Management and Administrative Procedures for Cases Designated as Complex Chapter 11 Cases as set forth at Exhibit F to the Court's General Order Governing Procedures for Complex Chapter 11 Cases shall apply; and it is further

ORDERED that hearings on any motions or contested matters shall be held every other Wednesday at 10:00 a.m. beginning with October 28, 2020 and following on November 12, 2020 (Thursday), November 25, 2020, December 9, 2020 and December 23, 2020. All hearings shall be telephonic through Court Solutions unless otherwise ordered by the Court. All motions filed in this case must be scheduled for a hearing date in accordance with this Order, unless otherwise ordered by the Court; and it is further

ORDERED that there shall be a status conference each Wednesday at 3:00 p.m. of every week that there is not a motion hearing beginning on October 21, 2020. All status conferences shall be telephonic through Court Solutions unless otherwise ordered by the Court. The day before
