PLEASE TAKE FURTHER NOTICE that on January 21, 2015, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed the *Debtors’ Amended Motion to Reschedule Status Hearing for February 2, 2015, at 3:00 p.m. (Prevailing Central Time)* [Docket No. 115] (the “Amended Motion”), which seeks to reschedule the Status Hearing to 3:00 p.m. (Prevailing Central Time) on February 2, 2015.

PLEASE TAKE FURTHER NOTICE that on the **28th of January, 2015, at 10:00 a.m. (prevailing Central Time)**, or as soon thereafter as counsel may be heard, the Debtors shall appear before the Honorable A. Benjamin Goldgar or any other judge who may be sitting in his place and stead, in Courtroom 642 in the United States Courthouse, 219 South Dearborn Street, Chicago, Illinois 60604, and present the Amended Motion.

PLEASE TAKE FURTHER NOTICE that any objection to the Amended Motion must be filed with the Court, and served so as to be actually received by each of the following entities, by **January 26, 2015, at 4:00 p.m. (prevailing Central Time)**: (a) counsel to the Debtors; (b) the Office of the United States Trustee for the Northern District of Illinois; (c) the entities listed on the *Consolidated List of Creditors Holding the 50 Largest Unsecured Claims*; (d) the
