The Debtors' Third Amended Joint Plan of Reorganization Pursuant to Chapter 11 of the Bankruptcy Code (the "Plan") was confirmed by the United States Bankruptcy Court for the Northern District of Illinois, Eastern Division on January 17, 2017. As part of the mandatory exchange of the above referenced securities, holders will receive new securities in accordance with the chart set forth below. The CUSIP numbers for the new

securities are as follows: (i) CEC Common Stock (CUSIP 127686 103), (ii) CEC Convertible Notes (CUSIP 127686 AA1), (iii) PropCo First Lien Notes (CUSIP 925651 AB7), (iv) PropCo Second Lien Notes (CUSIP 925651 AA9), (v) VICI Common Stock (CUSIP 925652 109), and (vi) VICI Preferred Stock is (CUSIP 925652 208).
