Upon consideration of the application (the “**Application**”)² of the above captioned debtors and debtors-in-possession (collectively, the “**Debtors**”) for entry of an order designating the within matters as Complex Chapter 11 Cases filed on November 10, 2015 [Docket No. 3] under the Court’s *General Order Authorizing Procedures for Complex Chapter 11 Cases* dated November 25, 2009; and the Court having entered an *Order Granting Complex Chapter 11 Treatment* on November 13, 2015 [Docket No. 23]; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334 and the *Standing Order of Reference to the Bankruptcy Court Under Title 11* dated as of September 18, 2012 (Simandle, C.J.); and it appearing that the procedures set forth herein will enhance the efficient administration of these Chapter 11 Cases; and the Court having determined that the relief set forth herein is in the best interests of the Debtors, their estates and creditors; and after due deliberation and sufficient cause appearing therefor;
