Upon the *Liquidating Trustee's Fifth Omnibus Objection to Certain Claims Pursuant to 11 U.S.C. § 502(b) and Fed. R. Bankr. P. 3007(d)* (the "Fifth Omnibus Objection") [Dkt. No. 972] filed by Bernard M. Katz, as Liquidating Trustee (the "Liquidating Trustee") for the estates of EOGH Liquidation, Inc. (f/k/a East Orange General Hospital, Inc.) ("EOGH") and EVHI Liquidation, Inc. (f/k/a Essex Valley Healthcare, Inc.) ("EVHI", and together with EOGH, the "Debtors"), through his attorneys, Trenk, DiPasquale, Della Fera, & Sodono, P.C.; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and venue being proper in this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and notice of the Fifth Omnibus Objection being sufficient under the circumstances; and it appearing that no other or further notice need be provided; and the Court having determined that the relief sought in the Fifth Omnibus Objection is in the best interests of Debtors' estates and creditors; and after due deliberation and sufficient cause appearing therefor;

**IT IS HEREBY ORDERED THAT:**

1. The Fifth Omnibus Objection is GRANTED as set forth herein.
2. The claims identified in Exhibit A annexed hereto (the "Duplicate and Surviving Claims"), which are duplicative of other proofs of claim, are disallowed to the extent they are duplicative and the remaining claim is sustained in the amount set forth in the "Surviving Claim" column of Exhibit A.
3. The claims identified in Exhibit B (the "Duplicate and Adjusted Claims"), which are duplicative of other proofs of claim and are either inconsistent with Debtors' books and records

or have been assumed by Prospect, are disallowed to the extent that they are duplicative and the remaining claims are adjusted pursuant to the "Surviving Claim" column of Exhibit B.

4. The claims identified on Exhibit C annexed hereto (the "Amended and Surviving Claims"), which amend earlier proofs of claim and exceed the amount of liability reflected in Debtors' books and records, are adjusted pursuant to the "Surviving Claim" column of Exhibit C.

5. The claims identified in Exhibit D (the "Late Filed Claims"), which were filed after the applicable claims bar dates had passed, are disallowed in their entirety. The Liquidating Trustee's claims agent is authorized and directed to permanently expunge the Late Claims from the claims register.

6. The Fifth Omnibus Objection is adjourned to **September 12, 2017 at 10:00 a.m.** as to the following claims and claimants:

- a. Claim Nos. 102 and 287 filed by National Research Corporation ("NRC");
- b. Claim No. 295 filed by Hospira Worldwide, Inc. ("Hospira");
- c. Claim No. 147 filed by GE Healthcare Life Sciences;
- d. Claim No. 152 filed by GE Healthcare MDX; and
- e. Claim No. 437 filed by GE Healthcare Datex.

7. Any responses to the Fifth Omnibus Objection from parties holding adjourned claims shall be filed with the Bankruptcy Court and shall be served upon counsel for the Liquidating Trustee so as to be received by no later than **September 5, 2017 at 4:00 p.m.**
