Sontchi, United States Bankruptcy Judge for the United States Bankruptcy Court for the District of Delaware, entered the *Order Approving the Debtors’ Disclosure Statement for and Confirming the First Modified Joint Prepackaged Chapter 11 Plan of Reorganization of EV Energy Partners, L.P. and Its Debtor Affiliates* [Docket No. 238] confirming the chapter 11 plan of reorganization and approving the related disclosure statement of the above-captioned debtors (the “Debtors”).

**PLEASE TAKE FURTHER NOTICE** that, on June 4, 2018, the effective date of the Debtors’ chapter 11 plan occurred, and the Debtors emerged from chapter 11.
