**PLEASE TAKE FURTHER NOTICE THAT** pursuant to the authority granted by the Court in the *Order: (A) Approving Disclosure Statement; (B) Fixing Voting record Date; (C) Approving Solicitation Materials and Procedures for Distribution Thereof; (D) Approving Forms of Ballots and Establishing Procedures for Voting on Plan; (E) Scheduling Hearing and Establishing Notice and Procedures for Filing Objections to (I) Confirmation of the Plan, and (II) Proposed Cure Amounts Related to Contracts Assumed; (F) Authorizing Amendments to the Plan and Disclosure Statement and Shortening Notice in the Event of an Alternative Transaction and (G) Granting Related Relief* [Docket No. 732], **the Confirmation Hearing has been adjourned to a date to be determined. The Debtors will file and serve notice of the Confirmation Hearing no less than ten days before the hearing is scheduled to occur.**
