PLEASE TAKE NOTICE THAT the hearing to consider confirmation of the *First Amended Joint Chapter 11 Plan of Reorganization* [Docket No. 1413] (as may be amended, modified, or supplemented, the “Plan”)<sup>2</sup> is **adjourned to May 27, 2020 at 1:00 p.m.** (the “Confirmation Hearing”).

**PLEASE TAKE FURTHER NOTICE** that on March 13, 2020, the United States Bankruptcy Court for the Eastern District of Virginia (the “Court”) entered an order [Docket No. 1426] (the “Disclosure Statement Order”): (i) approving the adequacy of the Disclosure Statement, (ii) approving the solicitation materials and notices relating to the Disclosure Statement and the Plan, (iii) approving the forms of Ballots and the Election Form, (iv) establishing procedures for distributing the Solicitation Packages, voting on the Plan and tabulating votes, (v) scheduling a hearing regarding confirmation of the Plan, and (vi) establishing notice and objection procedures with respect to the confirmation of the Plan.

**PLEASE TAKE FURTHER NOTICE** that the Disclosure Statement Order established certain deadlines, including, among other things, the deadline for parties to file objections to the Plan, the deadline for filing the Plan Supplement, the Voting Deadline, the Election Deadline (the “Deadlines”).

**PLEASE TAKE FURTHER NOTICE**, in connection with the Confirmation Hearing, and in light of the ongoing COVID-19 pandemic, and its impact on the Court and the various parties in interest, the Debtors are extending certain Deadlines as set forth below:<sup>3</sup>

**PLEASE TAKE FURTHER NOTICE THAT** the Plan may be modified, if necessary, pursuant to section 1127 of the Bankruptcy Code, before, during or as a result of the Confirmation Hearing, without further notice to interested parties.

**PLEASE TAKE FURTHER NOTICE THAT** all Election Forms must be completed with all of the required information on the Election Form and executed and returned according to and as set forth in detail in the Election Form instructions so that it is actually received by the Solicitation Agent on or before the Election Deadline.
