**NOTICE OF FURTHER RESCHEDULED HEARING TO CONSIDER  
APPROVAL OF (A) DISCLOSURE STATEMENT [DOCKET NO. 137]  
AND (B) DISCLOSURE STATEMENT MOTION [DOCKET NO. 142]**

PLEASE TAKE NOTICE that, on June 22, 2020, Libbey Glass Inc. and its affiliated debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “**Debtors**”) filed the *Disclosure Statement for the Joint Plan of Reorganization for Libbey Glass Inc. and Its Affiliate Debtors Under Chapter 11 of the Bankruptcy Code* [Docket No. 137] (as may be amended from time to time, the “**Disclosure Statement**”), and on June 23, 2020, the Debtors filed the *Motion of the Debtors for Entry of an Order (A) Approving the Disclosure Statement, (B) Establishing the Voting Record Date, Voting Deadline and Other Dates, (C) Approving Procedures for Soliciting, Receiving and Tabulating Votes on the Plan and for Filing Objections to the Plan and (D) Approving the Manner and Forms of Notice and Other Related Documents* [Docket No. 142] (the “**Disclosure Statement Motion**”) and the *Notice of*

PLEASE TAKE FURTHER NOTICE that, pursuant to the Notice of Disclosure Statement Hearing, objections (each an “**Objection**”) to the adequacy of the Disclosure Statement or the relief sought in connection with the Disclosure Statement Motion were to be filed with the Bankruptcy Court on or before July 21, 2020 at 4:00 p.m. (prevailing Eastern Time) (the “**Objection Deadline**”) and be served on the Notice Parties. **Unless otherwise agreed to by the Debtors, the Objection Deadline has not changed.**

PLEASE TAKE FURTHER NOTICE that only those Objections that were timely filed with the Bankruptcy Court in accordance with the Notice of Disclosure Statement Hearing and served on the Notice Parties will be heard at the Disclosure Statement Hearing.
