**DEBTORS' FIRST OMNIBUS OBJECTION TO CERTAIN
PROOFS OF CLAIM (AMENDED CLAIMS AND DUPLICATE CLAIMS)**

THIS IS AN OBJECTION TO YOUR CLAIM. THE OBJECTING PARTY IS ASKING THE COURT TO DISALLOW THE CLAIM THAT YOU FILED IN THIS BANKRUPTCY CASE. YOU SHOULD IMMEDIATELY CONTACT THE OBJECTING PARTY TO RESOLVE THE DISPUTE. IF YOU DO NOT REACH AN AGREEMENT, YOU MUST FILE A RESPONSE TO THIS OBJECTION AND SEND A COPY OF YOUR RESPONSE TO THE OBJECTING PARTY. YOUR RESPONSE MUST STATE WHY THE OBJECTION IS NOT VALID.

UNDER THE COURT'S ORDER SETTING OMNIBUS CLAIMS PROCEDURES [DOCKET NO. 1312], IF YOU DO NOT FILE A RESPONSE BY 4:00 P.M. (PREVAILING CENTRAL TIME) ON JANUARY 9, 2017, YOUR CLAIM MAY BE DISALLOWED WITHOUT A HEARING.

A HEARING WILL BE CONDUCTED ON THIS MATTER ON FEBRUARY 10, 2017 AT 2:00 P.M. IN COURTROOM 400, 4TH FLOOR, UNITED STATES BANKRUPTCY COURT FOR THE SOUTHERN DISTRICT OF TEXAS, 515 RUSK STREET, HOUSTON, TEXAS 77002.

REPRESENTED PARTIES SHOULD ACT THROUGH THEIR ATTORNEY.

THIS OBJECTION SEEKS TO DISALLOW AND EXPUNGE CERTAIN PROOFS OF CLAIM. CLAIMANTS RECEIVING THIS OBJECTION SHOULD LOCATE THEIR NAMES AND CLAIMS ON SCHEDULES 1-2 TO EXHIBIT A ATTACHED TO THIS OBJECTION.

The above-captioned debtors and debtors in possession (collectively, the “Debtors”) respectfully state as follows in support of this omnibus claims objection (this “Objection”), and submit the *Declaration of Barry Folsie in Support of Debtors’ First Omnibus Objection to Certain Proofs of Claim (Amended Claims and Duplicate Claims)*, attached hereto as **Exhibit B** (the “Folsie Declaration”):

Relief Requested

1. The Debtors seek entry of an order, substantially in the form attached hereto as **Exhibit A** (the “Order”):

- disallowing and expunging each claim identified on **Schedule 1** to the Order (collectively, the “Amended Claims”) in its entirety because each such claim was amended and replaced by the “Remaining Claims” and
- disallowing and expunging each claim identified on **Schedule 2** to the Order (collectively, the “Duplicate Claims”) in its entirety because each such claim duplicates other proofs of claim filed against the same Debtor, despite such claimants having a single potential claim against such Debtor.

Jurisdiction, Venue, and Procedural Background

2. The United States Bankruptcy Court for the Southern District of Texas (the “Court”) has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2). Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409. The bases for the relief requested in this Motion are sections 105(a) and 502(b) of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 (the “Bankruptcy Code”), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), and Rule 3007-1 of the Bankruptcy Local Rules for the Southern District of Texas.

3. On May 11, 2016, each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code (the “Petition Date”). A detailed description of the facts and

circumstances leading to these chapter 11 cases is set forth in the *Declaration of Arden L. Walker, Jr., Chief Operating Officer of Linn Energy, LLC, in Support of Chapter 11 Petitions and First Day Motions* [Docket No. 19].

4. The Debtors continue to operate and manage their businesses as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. On May 23, 2016, the Office of the United States Trustee for the Southern District of Texas (the “U.S. Trustee”) appointed an official committee of unsecured creditors (the “Committee”) [Docket No. 159].

The Claims Reconciliation Process

5. On July 11, 2016 and July 12, 2016, the Debtors filed their statements of financial affairs and schedules of assets, liabilities, current income, expenditures, executory contracts, and unexpired leases, as required by section 521 of the Bankruptcy Code (collectively, the “Schedules”). On August 4, 2016, the Court entered an order [Docket No. 756], which, among other things, established (a) September 16, 2016, as the deadline for all non-governmental entities holding or wishing to assert a “claim” (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the “General Bar Date”) and (b) November 7, 2016, as the deadline for all governmental entities holding or wishing to assert a “claim” (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the “Government Bar Date”).

6. On December 8, 2016, the Court entered the *Order Approving Omnibus Claims Objection Procedures and Filing of Substantive Omnibus Objections* [Docket No. 1312], approving the Debtors’ proposed objection procedures (the “Objection Procedures”). This Objection is filed in accordance with the Objection Procedures.

7. To date, entities have filed approximately 7,700 proofs of claim against the Debtors on an aggregate basis. The Debtors and their advisors have been working diligently to review these proofs of claim, including any supporting documentation filed therewith. For the reasons set forth below, and based on their review to date, the Debtors have determined that the Amended Claims and Duplicate Claims disputed herein (each, a “Disputed Claim,” and, collectively, the “Disputed Claims”) should be disallowed and expunged as set forth herein.

Basis for Relief

8. Section 502 of the Bankruptcy Code provides, in pertinent part, as follows: “[a] claim or interest, proof of which is filed under section 501 of [the Bankruptcy Code], is deemed allowed, unless a party in interest . . . objects.” 11 U.S.C. § 502. Moreover, Bankruptcy Rule 3007 provides certain grounds upon which “objections to more than one claim may be joined in an omnibus objection,” which includes when “the objections are based solely on the grounds that the claims should be disallowed, in whole or in part, because . . . they duplicate other claims” or “they have been amended by subsequently filed proofs of claim.” Fed. R. Bankr. P. 3007(d).

9. As set forth in Bankruptcy Rule 3001(f), a properly executed and filed proof of claim constitutes prima facie evidence of the validity and the amount of the claim under section 502(a) of the Bankruptcy Code. *See, e.g., In re Jack Kline Co., Inc.*, 440 B.R. 712, 742 (Bankr. S.D. Tex. 2010). A proof of claim loses the presumption of prima facie validity under Bankruptcy Rule 3001(f) if an objecting party refutes at least one of the allegations that are essential to the claim’s legal sufficiency. *See In re Fidelity Holding Co., Ltd.*, 837 F.2d 696, 698 (5th Cir. 1988). Once such an allegation is refuted, the burden reverts to the claimant to prove the validity of its claim by a preponderance of the evidence. *Id.* Despite this shifting burden during the claim objection process, “the ultimate burden of proof always lies with the claimant.”

In re Armstrong, 347 B.R. 581, 583 (Bankr. N.D. Tex. 2006) (citing *Raleigh v. Ill. Dep't of Rev.*, 530 U.S. 15 (2000)).

I. Amended Claims.

10. As set forth in the Folsie Declaration, the Debtors have determined that the Amended Claims identified on **Schedule 1** to the Order were amended and replaced by the “Remaining Claims” identified on **Schedule 1** to the Order (the “Remaining Amended Claims”). To allow both the Amended Claims and Remaining Amended Claims to remain on the claims register would be duplicative and would lead to multiple recoveries on a single claim. Accordingly, the Debtors respectfully request that the Court enter the Order expunging and disallowing the Amended Claims identified on **Schedule 1** to the Order. This Objection does not affect the Remaining Amended Claims identified on **Schedule 1** to the Order, and the Debtors reserve their right to object to the Remaining Amended Claims on any grounds whatsoever.

II. Duplicate Claims.

11. As set forth in the Folsie Declaration, the Debtors have reviewed their books and records and the claims register and have determined that the Duplicate Claims in the rows titled “Claim To Be Expunged” on **Schedule 2** to the Order duplicate the claims in the rows titled “Remaining Claim” identified on **Schedule 2** to the Order (the “Remaining Duplicate Claims”). Failure to disallow and expunge the Duplicate Claims would result in the applicable claimants receiving an unwarranted recovery against the Debtors to the detriment of other similarly situated creditors, or provide the holders of such Duplicate Claims multiple votes on a chapter 11 plan. Accordingly, the Debtors request that the Court enter an order disallowing and expunging those Duplicate Claims identified on **Schedule 2** to the Order. This Objection does not affect the Remaining Duplicate Claims, and the Debtors reserve their right to object to the Remaining Duplicate Claims on any grounds whatsoever.

Reservation of Rights

12. This Objection is limited to the grounds stated herein. Accordingly, it is without prejudice to the rights of the Debtors or any other party in interest to object to any claim on any grounds whatsoever, and the Debtors expressly reserve all further substantive or procedural objections they may have. Nothing contained herein or any actions taken pursuant to such relief is intended or should be construed as: (a) an admission as to the validity of any prepetition claim against a Debtor entity; (b) a waiver of any party's right to dispute any prepetition claim on any grounds; (c) a promise or requirement to pay any prepetition claim; (d) an implication or admission that any particular claim is of a type specified or defined in this Objection or any order granting the relief requested by this Objection; (e) a request or authorization to assume any prepetition agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of the Debtors' rights under the Bankruptcy Code or any other applicable law.

Separate Contested Matter

13. To the extent that a response is filed regarding any Disputed Claim and the Debtors are unable to resolve any such response, each such Disputed Claim, and the Objection as it pertains to such Disputed Claim, will constitute a separate contested matter as contemplated by Bankruptcy Rule 9014. Further, the Debtors request that any order entered by the Court regarding an objection or other reply asserted in response to this Objection be deemed a separate order with respect to each proof of claim.

Notice

14. The Debtors will provide notice of this Motion to: (a) the Office of the United States Trustee for the Southern District of Texas; (b) counsel to the official committee of unsecured creditors; (c) counsel to Wells Fargo Bank, N.A., as administrative agent under LINN's prepetition credit facility and Berry's prepetition credit facility; (d) counsel to

Wilmington Trust Company, as successor indenture trustee for LINN's 6.50% senior unsecured notes due 2019, 6.25% senior unsecured notes due 2019, 8.625% senior unsecured notes due 2020, 7.75% senior unsecured notes due 2021, and 6.5% senior unsecured notes due 2021; (e) counsel to the ad hoc group of LINN 12% second lien notes due 2020; (f) counsel to the ad hoc group of holders of Berry's 6.75% senior unsecured notes due 2020 and 6.375% senior unsecured notes due 2022; (g) holders of a Disputed Claim; and (h) any party that has requested notice pursuant to Bankruptcy Rule 2002. The Debtors submit that, in light of the nature of the relief requested, no other or further notice need be given.

No Prior Request

15. No prior request for the relief sought in this Motion has been made to this or any other court.

6. Notwithstanding the relief granted in this Order and any actions taken pursuant to such relief, nothing in this Order shall be deemed: (a) an admission as to the validity of any prepetition claim against a Debtor entity; (b) a waiver of any party's right to dispute any prepetition claim on any grounds; (c) a promise or requirement to pay any prepetition claim; (d) an implication or admission that any particular claim is of a type specified or defined in this Objection or any order granting the relief requested by this Objection; (e) a request or authorization to assume any prepetition agreement, contract, or lease pursuant to section 365 of the Bankruptcy Code; or (f) a waiver of the Debtors' rights under the Bankruptcy Code or any other applicable law.

**DECLARATION OF BARRY FOLSE IN SUPPORT OF
DEBTORS’ FIRST OMNIBUS OBJECTION TO CERTAIN
PROOFS OF CLAIM (AMENDED CLAIMS AND DUPLICATE CLAIMS)**

I, Barry Folse, hereby declare under penalty of perjury:

1. I am a Managing Director at AlixPartners, LLP (“AlixPartners”). AlixPartners was retained by the above-captioned debtors (collectively, the “Debtors”) as restructuring advisor in connection with their chapter 11 cases. I have more than fifteen (15) years of restructuring experience. Since joining AlixPartners in 2001, I have provided restructuring advice within the context of chapter 11 restructurings, out-of-court restructurings, and distressed transactions.

2. I am generally familiar with the Debtors’ day-to-day operations, financing arrangements, business affairs, and books and records that reflect, among other things, the Debtors’ liabilities and the amount thereof owed to their creditors as of the Petition Date. I have

3. To the best of my knowledge, information, and belief, the assertions made in the Objection are accurate. In evaluating the Disputed Claims, the Debtors and AlixPartners personnel have reviewed the Debtors' books and records and the relevant proofs of claim, as well as the supporting documentation provided by each claimant, and have determined that each Disputed Claim should be disallowed and expunged. As such, I believe that the disallowance and expungement of the Disputed Claims on the terms set forth in the Objection is appropriate.

I. Amended Claims.

4. The Debtors have determined that each Disputed Claim listed on Schedule 1 of the Order in the rows titled "Claim to be Disallowed" (collectively, the "Remaining Amended Claims") amends and replaces other proofs of claim filed by or on behalf of the same claimant in respect of the same liabilities. Failure to disallow and expunge the Remaining Amended Claims could potentially result in the relevant claimants receiving double recoveries against the Debtors to the detriment of other creditors. As such, I believe that disallowance and expungement of the Remaining Amended Claims on the terms set forth in the Objection and Schedule 1 is appropriate.

II. Duplicate Claims.

5. The Debtors have determined that each Disputed Claim listed on Schedule 2 of the Order in the rows titled "Claim to be Disallowed" (collectively, the "Remaining Duplicate Claims") is duplicative of other proofs of claim filed by or on behalf of the same claimant in respect of the same liabilities. Failure to disallow and expunge the Remaining Duplicate Claims
