**NOTICE OF CANCELLATION OF THE HEARING

PLEASE TAKE NOTICE that the hearing scheduled for **December 4, 2019, at 9:30 a.m., prevailing Eastern Time**, before the Honorable John E. Hoffman, Jr., United States Bankruptcy Judge, United States Bankruptcy Court for the Southern District of Ohio, Courtroom A, 5th Floor, 170 North High Street, Columbus, Ohio 43215 (the “Court”), **has been cancelled.**

PLEASE TAKE FURTHER NOTICE that on December 2, 2019, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed (a) *Certificate of No Objection Regarding Order (I) Authorizing the Rejection of Certain Executory Contract Effective Nunc Pro Tunc to the Petition Date and (II) Granting Related Relief, and Notice of Filing New Proposed Form of Order* [Docket No. 308], (b) *Certificate of No Objection Regarding Final Order Authorizing the Debtors to (A) Continue their Insurance Policies and Honor all Obligations in Respect Thereof, (B) Renew, Supplement, and Enter into New Insurance Policies, (C) Honor the Terms of Premium Financing Agreements and Pay Premiums*
