**NOTICE OF MODIFIED SALE PROCESS DATES**

PLEASE TAKE NOTICE that on February 8, 2016, the debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “Debtors”) filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code.

PLEASE TAKE FURTHER NOTICE that, on February 29, 2016, the Debtors filed their Motion (the “Motion”) for (I) an Order Establishing Bidding Procedures for the Downstream Business and Granting Related Relief and (II) an Order Approving the Sale of the Downstream Business. By the Motion, the Debtors sought to sell (the “Sale”) the Debtors’ flat rolled products business owned and operated by Norandal USA, Inc. (the “Downstream Business”) at the rolling mills in (a) Huntingdon, Tennessee, (b) Newport, Arkansas, and (c) Salisbury, North Carolina, together with any assets, facilities, real property, personal property, plants, equipment, inventory, and accounts receivable associated therewith (collectively, the “Subject Assets”) and to assume and assign certain executory contracts and unexpired leases related to the Subject Assets to the Stalking Horse Bidder (if any) and/or one or more Successful Bidder(s) at the Auction, as applicable.

PLEASE TAKE FURTHER NOTICE that, on March 21, 2016, the Court entered the order approving auction and bidding procedures (the “Bidding Procedures”) in connection with the proposed Sale of the Downstream Business [D.I. 471] (the “Bidding Procedures Order”). The Bidding Procedures Order approved the following dates related to the Sale (the “Sale Process Dates”): (i) May 26, 2016 at 5:00 p.m. (prevailing Eastern Time) as the deadline for bidders to submit bids (the “Bid Deadline”); (ii) May 31, 2016 at 5:00 p.m. (prevailing Central Time) as the deadline for filing objections, if any, to the Sale; (iii) June 2, 2016 at 10:00 a.m. (prevailing Eastern Time) as the date and time for the Auction; and (iv) June 9, 2016 at 10:00 a.m. (prevailing Central Time) as the date and time for the Sale Hearing. Copies of the Motion, the Bidding Procedures Order and this Notice may be obtained by interested parties free of charge on <https://cases.primeclerk.com/noranda>.

PLEASE TAKE FURTHER NOTICE that, pursuant to the Bidding Procedures Order, the Debtors are authorized to modify (in consultation with the Consultation Parties or Bid Consultation Parties, as applicable) the Bidding Procedures as an exercise of the Debtors' fiduciary duties and for the purpose of maximizing value for their estates from the sale process.

PLEASE TAKE FURTHER NOTICE that the Debtors, in an exercise of their rights pursuant to the Bidding Procedures Order, and having consulted with the Consultation Parties or Bid Consultation Parties, as appropriate, have modified the Sale Process Dates (the "Modified Sale Process Dates") as follows:
