PLEASE TAKE FURTHER NOTICE that any objection or other response (collectively, “Objections”) to the entry of an order approving the Cash Collateral Motion must be filed on or before **June 2, 2015 at 12:00 p.m. (Eastern Time)** (the “Objection Deadline”) with the Clerk of the Bankruptcy Court, 824 N. Market Street, 3rd Floor, Wilmington, Delaware 19801. At the same time, you must serve a copy of the Objection upon the undersigned.

IF YOU FAIL TO RESPOND TO THE CASH COLLATERAL MOTION IN ACCORDANCE WITH THIS NOTICE, THE COURT MAY GRANT THE RELIEF REQUESTED WITHOUT FURTHER NOTICE OR OPPORTUNITY FOR A HEARING.
