PLEASE TAKE NOTICE that on June 5, 2015, the above-captioned debtors and debtors-in-possession (the “Debtors”) filed the **Debtors’ Motion for an Order (I) Scheduling Combined Hearing on Approval of Disclosure Statement and Confirmation of Plan, (II) Establishing Procedures for Solicitation and Tabulation of Votes on Plan and (III) Approving Related Matters** (Docket No. 2347) (the “Solicitation Motion”).

PLEASE TAKE FURTHER NOTICE that on June 5, 2015, the Debtors filed the **Motion for Order Expediting Consideration of, and Shortening the Notice Period Applicable to, Debtors’ Motion for an Order (I) Scheduling Combined Hearing on Approval of Disclosure Statement and Confirmation of Plan, (II) Establishing Procedures for Solicitation and Tabulation of Votes on Plan and (III) Approving Related Matters** (Docket No. 2348) (the “Motion to Shorten Notice”).

PLEASE TAKE FURTHER NOTICE that upon the United States Bankruptcy Court for the District of Delaware’s (the “Bankruptcy Court”) review of the Solicitation Motion and the Motion to Shorten Notice, the Bankruptcy Court has set **June 25, 2015 at 9:30 a.m. (Eastern Time)** for the hearing on the Solicitation Motion. The hearing is scheduled to be held before the Honorable Brendan L. Shannon, Chief United States Bankruptcy Judge, at the United States Bankruptcy Court for the District of Delaware, 6th Floor, Courtroom No. 1, 824 Market Street, Wilmington, Delaware.

PLEASE TAKE FURTHER NOTICE THAT IF YOU FAIL TO RESPOND TO THE SOLICITATION MOTION IN ACCORDANCE WITH THIS NOTICE, THE BANKRUPTCY COURT MAY GRANT THE RELIEF REQUESTED IN THE SOLICITATION MOTION WITHOUT FURTHER NOTICE OR OPPORTUNITY FOR A HEARING.
