NEW ADVENTURES, LLC LTDs JOINDER IN THE LIMITED OBJECTION FILED BY CRAYOLA LLC [DOCKET NO. 2368] AND THE LIMITED OBJECTION FILED BY OMNIBUS POST-PETITION VENDORS [DOCKET NO. 2446]

New Adventures, LLC Ltd (“New Adventures”), by and through its undersigned counsel, hereby submits this joinder to the limited objections filed by Crayola LLC [Docket No. 2368] and by the Post-Petition Vendors [Docket No. 2446] (collectively, the “Objections”) to *Debtors’ Motion for Entry of an Order (A) Authorizing the North American Debtors’ Entry Into Waivers With Respect to ABL/FILO DIP Documents and the Term DIP Documents and (B) Amending Final Order (I) Authorizing the North American Debtors to Obtain Postpetition Financing, (II) Authorizing the North*

American Debtors to Use Cash Collateral, (III) Granting Liens and Providing Superpriority Administrative Expense Status, (IV) Granting Adequate Protection to the Prepetition Lenders, (V) Modifying the Automatic Stay, and (VI) Granting Related Relief (the “DIP Financing Motion”) [Docket No. 2189].

New Adventures is a long-standing vendor of the Debtors, having supplied the Debtors with private label and branded goods over the course of many years. In reliance upon the filed pleadings and representations made by the Debtors in this bankruptcy proceeding, New Adventures has, in good faith, continued to ship merchandise to the Debtors since the filing of the Chapter 11 bankruptcy proceedings on September 19, 2017 (the “Petition Date”). New Adventures is an administrative creditor of the Debtors and is owed no less than \$410,440.04 for goods shipped to the Debtors between December 2017 and February 2018.
